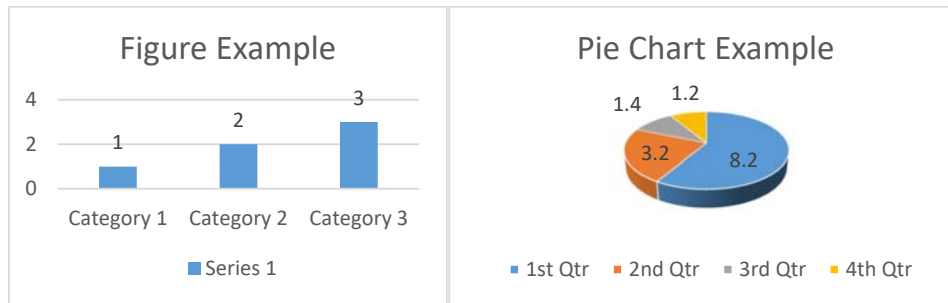


Figure 1: Title of figure
